

Schad's Remarkabull French Bulldogs Stud Service Contract

Heidi Schad agrees to provide stud services to the Dam Owner for the Dam listed below in this contract.

Up to 2 semen collections and evaluations will be provided per breeding & fees will be paid for by Heidi Schad.

Dam Owner agrees to notify Heidi Schad as soon as this female is beginning her heat cycle.

Dam Owner understands that the Stud Service Fee is to be paid in full prior to semen being shipped.

Each semen packaging and shipping fee is to be paid for by the Dam Owner.

Dam Owner agrees that once the semen is shipped, Heidi Schad has fulfilled her part in this stud service agreement. Dam Owner understands that the Stud Owner has no control of the package's arrival time or condition upon arrival, therefore there will be NO REFUND for stud services or shipping fees if the shipping company does not deliver at the promised time/date.

Dam Owner understands that progesterone testing is extremely important for an accurate breeding time.

Therefore, if progesterone testing is not done prior to requesting semen shipments, the Stud Owner will not offer a re-breed in the event that the Dam does not become pregnant or only 1 living puppy is born as a result of this stud service. If the Dam does not become pregnant or only 1 living puppy is born as a result of this stud service, and progesterone testing was done prior to requesting semen shipment(s), Heidi Schad will offer ONE free re-breed within 12 months of the initial stud service date, upon receiving proof from a licensed veterinarian. In the event that a re-breed is needed, the Dam Owner will be responsible

for all semen collection, evaluation, packaging, and shipping fees.

If a re-breed is offered and the Dam Owner chooses not to use it within the 12 months time, this contract agreement will be considered fulfilled by both parties.

Dam Owner agrees that 2 or more puppies born alive are considered a litter and this stud service is complete.

Dam Owner understands that stud services with Schad's Remarkabull French Bulldogs may not be sold or transferred to another person. This service must be used within 18 months from date service deposit or fee was paid.

If for any reason the Stud dies, becomes sick, or is unable to be bred prior to this stud services being fulfilled, this stud fee will be transferred to another stud owned by Heidi Schad.

If for any reason the Dam dies, becomes sick, or is unable to be bred prior to this stud service being fulfilled, this stud fee can be transferred to another approved Dam owned by the Dam Owner.
